Autodesk® is set to retire subscription plans based on serial numbers and is instead launching new subscription plans that are based on people. Like most SaaS providers, these plans are designed for named users and provide a range of administrative, support, and reporting capabilities for businesses of all sizes.

TRANSITION OPTIONS

Autodesk® has introduced trade-in offers to assist users who will be transitioning from multi-user to named user licenses. Users who will proceed with this will enjoy the same renewal price with ongoing discounts by 2028.



MAINTENANCE TRADE-IN

(started May 2020)

Switch to subscription upon renewal with the current maintenance price, an absolute 1:1 trade-in or stay on maintenance, but there will be a 20% price increase upon renewal agreement.



MULTI-USER TRADE-IN

(started August 2020)

Switch or stay? In choosing the switch option, users will be able to trade one multi-user license for two standard named-user licenses. Otherwise, a switch to one multi-user license to one standard user upon the next renewal will be forcefully applied.

WHAT IS A

NAMED-USER SUBSCRIPTION?

It is where each individual user must maintain an account (instead of using a network license or perpetual serial number). Companies that still have maintenance plans on perpetual licenses will no longer be supported. Named-user subscription has several advantages, including a wide overview of usage data, dedicated license access for employees, tailored support and learning contents, and no need to manage your own license servers.
